



2018 Run For MS 'Refer a Friend and Fundraise' Prize Draw Competition Terms & Conditions

Information on how to enter forms part of these Terms of Entry. Entry into the competition is deemed acceptance of these Terms and Conditions.

1. Multiple Sclerosis Limited (MSL) is the Promoter. MSL takes no responsibility for the prize.
2. Entry is open to residents of Australia. Employees of Multiple Sclerosis Limited, their immediate families, any companies and agencies associated with the Promotion are not eligible to enter.
3. The competition commences at 9am on Tuesday 2 January 2018 (AEDT) for all event specific prize draws.
 - 3.1 The City2Surf prize draw closes at 11:59pm on Thursday 12 July 2018.
 - 3.2 The Blackmores Sydney Running Festival prize draw closes at 11:59pm on Thursday 16 August 2018.
 - 3.3 The Melbourne Marathon Festival prize draw closes at 11:59pm on Friday 14 September 2018.
 - 3.4 The first general prize draw commences at 9am on Tuesday 2 January 2018 and closes at 11:59pm on Monday 30 April 2018.
 - 3.5 The second general prize draw commences on Tuesday 1 May 2018 and closes at 11:59pm on Saturday 30 June 2018.
 - 3.6 The final general prize draw commences on Sunday 1 July 2018 and closes at 11:59pm on Friday 30 November 2018.
 - 3.7 The Promotion Period concludes at 11:59pm on Friday 30 November 2018.
4. To be entered into the draw an individual must lodge \$250 fundraising on their online fundraising page between the competition commencement date and close date and time (AEST) for the relevant prize draw.
 - 4.1 Both participants must utilise their own online fundraising page and reach \$250 fundraising per page.
 - 4.2 For the event specific prize draws, both participants must be registered in the relevant event (City2Surf, Blackmores Sydney Running Festival, Melbourne Marathon Festival) and reach \$250 fundraising on their event online fundraising page.
 - 4.3 For the general prize draw, both participants must be registered in a multi-charity running, walking or challenge event which is not managed by Multiple Sclerosis Limited and must not include City2Surf, Blackmores Sydney Running Festival or Melbourne Marathon Festival.

The Promoter reserves the right to disqualify a winner if The Promoter becomes aware that the winner and/or the winner's entry is of a type described in this clause.
