



GAME 2GIVE SWEEPSTAKES OFFICIAL CONTEST RULES AND REGULATIONS (“Official Rules”)

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN

GAME 2GIVE Contest (the “Contest”) is powered by Bungie, Inc. (the “Sponsor”) in support of Children's Miracle Network Hospitals and Bungie Foundation. The Contest starts on December 1st, 2020 at 10:00 AM PST (the “Contest Opening Date”). The Contest closes at 11.59 PM PST on December 16, 2020 (the “Contest Closing Date”). There will be a random draw at 10:00 AM PST on December 21, 2020 amongst all eligible entries.

1. ELIGIBILITY:

The Contest is open to all individuals who have reached the age of majority in their country, state, province and territory of their residence at the time of entry. All other entrants under the age of majority will require parental consent to participate in the Contest. Subject to the age limitation provided above, entrants who are under the age of majority in their country, state, province and territory of residence at the date of entry are still eligible to enter the Contest and win a Prize provided that the parent or legal guardian of the entrant accepts the Prize and the terms and conditions hereof for and on behalf of such entrant and completes the required Declaration and Release Form (as further outlined below).

2.b NO DONATION NECESSARY

Upon receiving a no purchase necessary request, a receipt confirmation will be send via email.

Submissions will be declared invalid if they are late, illegible and contain profanity. The Sponsor reserves the right to disqualify all such entrants from future contests conducted by the Sponsor without further notice.

3. PRIZING

There are two hundred and fifty-seven (257) prizes in total. The Prizes must be accepted as awarded without substitution and are not refundable, for resale or convertible to cash. Alternatively, the winner may transfer the prize to an immediate family member who complies with these rules and regulations. The Sponsor bears no liability relating to the prize once it is delivered. If the selected entrant for the Prize

forfeits the Prize, it may be awarded to another entrant, at the sole option of the Sponsor.

The Sponsor reserves the right, in the event that the Prize, or any component of the Prize, cannot be awarded as described for any reason, to substitute the same for another prize or component of equal or greater value, without liability.
