Guidelines for ALL exhibitors and non-profits

You are invited to the NAMIWalks Mercer County 2019 hosted by NAMI Mercer on Sunday, May 5, 2019 at Educational Testing Service located at 660 Rosedale Road, Princeton, New Jersey. We look forward to your participation and hope you will join us on a day where we will walk together to improve the lives of individuals and families who are affected by mental illness!

NAMIWalks Mercer County is a wonderful opportunity for our community to gather and share in a day filled with hundreds of people, music, and entertainment. **The Wellness Fair** is an outstanding way for local organizations and businesses to share knowledge of their services and educate the citizens within the greater Mercer community. For this year's Wellness Fair, NAMI Mercer asks that each exhibitor or non-profit be able to provide information that falls into at least one of the eight following categories as defined by **the Substance Abuse and Mental Health Services Administration**: emotional, financial, social, spiritual, occupational, physical, intellectual, or environmental; however, this is not required. Because NAMI Walks Mercer County is a community event for all ages, we ask that you consider bringing an activity suitable for children to your table. A table and two chairs are provided free of charge to NAMI Walks Mercer County at the Silver level (\$2,500) or higher, and discounted rates are available for other levels. Please review the modest fee schedule for other event sponsors or non-sponsors.

- You have the option to exhibit under our tent or outside of it. The Walk is a rain or shine event. Site regulations prohibit exhibitors from erecting tents or canopies on site.
- We are able to provide one table with 2 chairs per space.
- Please review the fee schedule. Our nominal fees cover our expenses to make this experience comfortable for exhibitors and attendees.
- Payment in the form of check/ money order/credit card is due with application no later than April 26, 2019.
- Application fees are NON-REFUNDABLE.

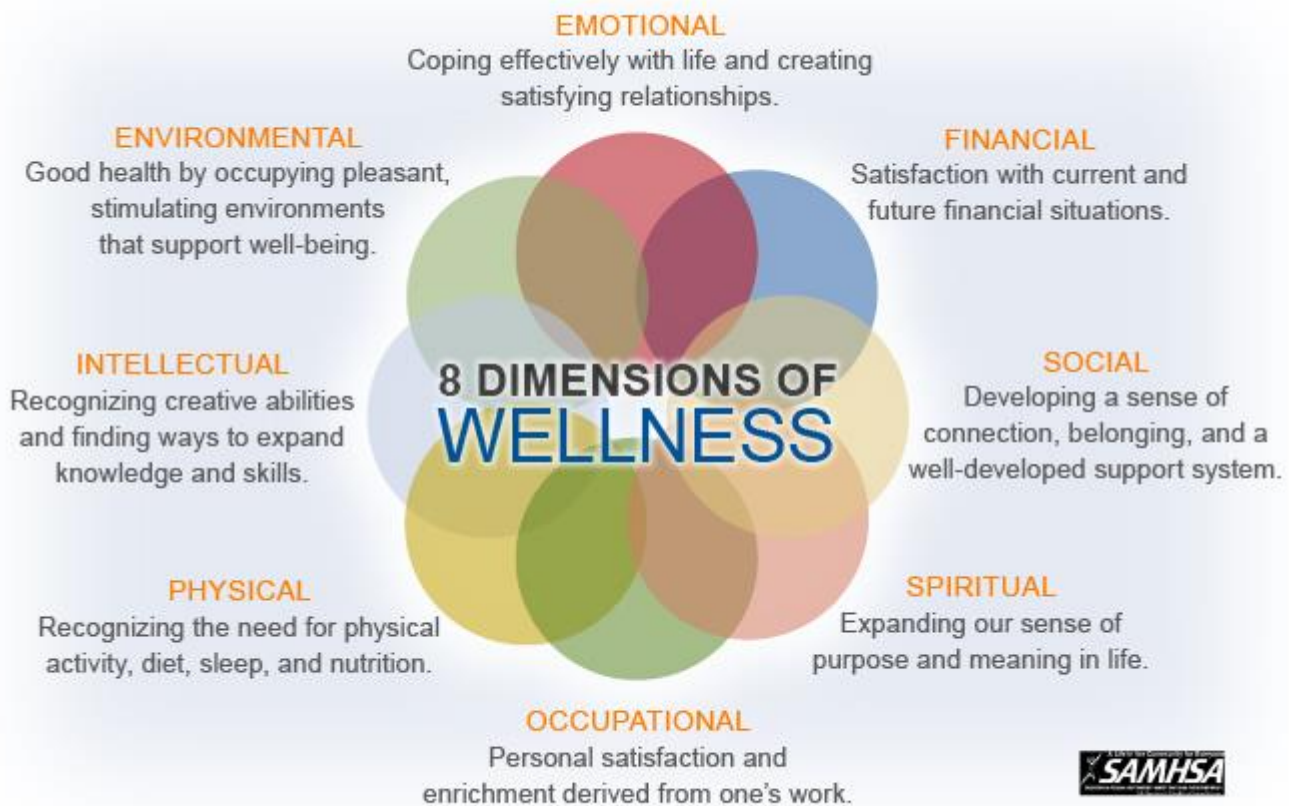

The Eight Dimensions of Wellness as defined by the Substance Abuse and Mental Health Services Administration (SAMHSA).



Examples of how one of the 8 dimensions of wellness would fit your organization

- A yoga instructor could explain the emotional, physical, and spiritual benefits of yoga.
- Meditation instruction would promote spiritual wellness
- A financial advisor or special needs attorney can offer occupational and financial information to the attendees.
- Environmental wellness can be addressed through improved conservation behaviors that one adapts in their home.
- An organization that hosts group activities for individuals across the lifespan can discuss the importance of social wellness.
- A poetry or literature group can assist with attendees understanding improved intellectual wellness.
